Powys County Council is holding a statutory consultation on a proposal to change the language category of Ysgol Bro Caereinion. The proposal is as follows:

To make a regulated alteration to alter the medium of instruction at Ysgol Bro Caereinion to Welsh-medium. This would be introduced on a phased basis, year-by-year, starting with Reception and Year 7 in September 2025

The consultation begins on 19 October 2023 and will end on 30 November 2023.
